Fact Sheet: U.S. Army North COVID-19 Vaccination Site Support (February-June 2021)

U.S. Army North, U.S. Northern Command's Joint Force Land Component Command, has overseen the Department of Defense's COVID-19 response operation in support of the Federal Emergency Management Agency and the Department of Health and Human Services since March 2020. This fact sheet reflects joint assistance to state and federal vaccination sites since February 2021.

Approximately 5,150 military medical and support personnel from the U.S. Army, U.S. Marine Corps, U.S. Navy and U.S. Air Force worked in 25 states and one territory as part of the federal vaccine response to the pandemic, administering approximately 5 million vaccines.

DoD Community Vaccination Center Support

As part of the whole-of-government response to the COVID-19 pandemic and sourced from Active Duty personnel identified after February 2021 to support federal vaccination efforts, which the Secretary of Defense initially announced, Feb. 4, 2021.

• California

- In California, 222 service members, who arrived Feb. 11, supported one CVC in one city from Feb. 16 to April 11.
 - One, 222-person, Type 1 Team from the U.S. Army supported the federal pilot Type 1 Community Vaccination Center at California State University Los Angeles in Los Angeles.

• Colorado

- In Colorado, approximately 140 service members, who arrived April 9, supported one CVC in one city from April 14 to June 15.
 - One, approximate 140-person, tailored Type 1 Team from the U.S. Army, modified at the request of the state to meet Type 2 CVC requirements, supported the federal pilot CVC at the Colorado State Fairgrounds in Pueblo.

• Florida

- In Florida, 556 service members, who arrived Feb. 26, supported four CVCs in four cities from March 3 to May 25.
 - One, 139-person, Type 2 Team from the U.S. Army supported the federal Type 2 CVC at Valencia College – West Campus in Orlando.
 - One, 139-person, Type 2 Team from the U.S. Army supported the federal pilot Type 2 CVC at Miami Dade Community College (North Campus) in Miami.
 - One, 139-person, Type 2 Team from the U.S. Navy supported the federal pilot Type 2 CVC at Gateway Mall in Jacksonville.

- One, 139-person, Type 2 Team from the U.S. Air Force supported the federal pilot Type 2 CVC at the Tampa Greyhound Track in Tampa.
- **Georgia**
 - In Georgia, 222 service members, who arrived March 19, supported one CVC in one city from March 24 to June 7.
 - One, 222-person, Type 1 Team from the U.S. Army supported the federal pilot Type 1 CVC at the Mercedes-Benz Stadium in Atlanta.
- **Illinois**
 - In Illinois, 222 service members, who arrived March 5, supported one CVC in one city from March 10 to May 24.
 - One, 222-person, Type 1 Team from the U.S. Army supported the federal pilot Type 1 CVC at the United Center in Chicago.
- **Indiana**
 - In Indiana, approximately 140 service members, who arrived April 2, supported one CVC in one city from April 7 to May 29.
 - One, approximate 140-person, Type 2 Team from the U.S. Air Force supported the federal pilot Type 2 CVC at the former Roosevelt High School in Gary.
- **Kentucky**
 - In Kentucky, approximately 30 service members, who arrived April 26, supported one CVC in one city from April 29 to June 10.
 - One, approximate 30-person, tailored Type 2 Team from the U.S. Army, modified at the request of the state to meet tailored Type 2 CVC requirements, supported the federal pilot CVC at the Henderson County Cooperative Extension Service in Henderson.
- **Louisiana**
 - In Louisiana, approximately 140 service members, who arrived April 11, supported one CVC in one city from April 16 to June 8.
 - One, approximate 140-person, Type 2 Team from the U.S. Marine Corps supported the federal pilot Type 2 CVC at the Bon Carré Business Center in Baton Rouge.
- **Maryland**
 - In Maryland, approximately 140 service members, who arrived April 2, supported one CVC in one city from April 7 to June 1.
 - One, approximate 140-person, Type 2 Team from the U.S. Air Force supported the federal pilot Type 2 CVC at the Greenbelt Metro Station in Greenbelt.

- **Massachusetts**

- In Massachusetts, approximately 220 service members, who arrived March 26, supported one CVC in one city from March 31 to May 23.
 - One, approximate 220-person, Type 1 Team from the U.S. Navy supported the federal pilot Type 1 CVC at the Hynes Convention Center in Boston.

- **Michigan**

- In Michigan, approximately 340 service members supported two vaccination sites in two cities.
 - One, 222-person, Type 1 Team from the U.S. Air Force, who arrived March 19, supported the federal pilot Type 1 CVC at Ford Field in Detroit from March 24 to May 18.
 - One, approximate 120-person, tailored Type 2 Team from the U.S. Air Force, who arrived April 23, supported the state vaccination site at DeVos Place in Grand Rapids from April 28 to May 7.

- **Minnesota**

- In Minnesota, approximately 140 service members, who arrived April 9, supported one CVC in one city from April 14 to June 8.
 - One, approximate 140-person, Type 2 Team from the U.S. Air Force supported the federal pilot Type 2 CVC at the Minnesota State Fairgrounds in St. Paul.

- **Missouri**

- In Missouri, approximately 140 service members, who arrived April 2, supported one CVC in one city from April 7 to June 1.
 - One, approximate 140-person, Type 2 Team from the U.S. Navy supported the federal pilot Type 2 CVC at The Dome at America's Center in St. Louis.

- **New Jersey**

- In New Jersey, approximately 220 service members, who arrived March 26, supported one CVC in one city from March 31 to June 22.
 - One, approximate 220-person, Type 1 Team from the U.S. Air Force supported the federal pilot Type 1 CVC at the New Jersey Institute of Technology Naimoli Family Athletic and Recreational Facility in Newark.

- **New York**

- In New York, 278 service members, who arrived Feb. 19, supported two CVCs in two cities from Feb. 24 to May 18.
 - One 139-person Type 2 Team from the U.S. Navy supported the federal pilot Type 2 CVC at York College in Jamaica.
 - One 139-person Type 2 Team from the U.S. Air Force supported the federal pilot Type 2 CVC at Medgar Evers College in Brooklyn.

- **North Carolina**

- In North Carolina, 139 service members, who arrived March 5, supported one CVC in one city from March 10 to May 27.
 - One, 139-person, Type 2 Team from the U.S. Air Force supported the federal pilot Type 2 CVC at the Four Seasons Town Centre in Greensboro.

- **Ohio**

- In Ohio, 222 service members, who arrived March 12, supported one CVC in one city from March 17 to June 7.
 - One, 222-person, Type 1 Team from the U.S. Army supported the federal pilot Type 1 CVC at Cleveland State University Wolstein Center in Cleveland.

- **Oklahoma**

- In Oklahoma, approximately 140 service members, who arrived April 16, supported one CVC in one city from April 21 to June 15.
 - One, approximate 140-person, tailored Type 1 Team from the U.S. Navy, modified at the request of the state to meet Type 2 CVC requirements, supported the federal pilot CVC at the Tulsa Community College Northeast Campus in Tulsa.

- **Oregon**

- In Oregon, approximately 100 service members, who arrived April 16, supported one CVC in one city from April 21 to June 15.
 - One, approximate 100-person, tailored Type 1 Team from the U.S. Marine Corps, modified at the request of the state to meet tailored Type 2 CVC requirements, supported the federal pilot CVC at the Jackson County Expo in Central Point.

- **Pennsylvania**

- In Pennsylvania, 222 service members, who arrived Feb. 26, supported one CVC in one city from March 3 to May 25.
 - One, 222-person, Type 1 Team from the U.S. Marine Corps supported the federal pilot Type 1 CVC at the Pennsylvania Convention Center in Philadelphia.

- **Tennessee**

- In Tennessee, approximately 140 service members, who arrived April 2, supported one CVC in one city from April 7 to May 19.
 - One, approximate 140-person, Type 2 Team from the U.S. Marine Corps supported the federal pilot Type 2 CVC at the Pipkin Building at the Liberty Bowl Memorial Stadium in Memphis.

- **Texas**

- In Texas, 500 service members, who arrived Feb. 19, supported six vaccination sites in four cities from Feb. 24 to May 18.

- One, 222-person, Type 1 Team from the U.S. Air Force supported the federal pilot Type 1 CVC at the NRG Center in Houston.
- One, 139-person, Type 2 Team from the U.S. Army supported the federal pilot Type 2 CVC at Fair Park Cotton Bowl Stadium in Dallas.
- One, 139-person, Type 2 Team from the U.S. Marine Corps supported the federal pilot Type 2 CVCs at Globe Life Field, AT&T Stadium and Esports Stadium Arlington in Arlington, and the state vaccination site at the Hurst Conference Center in Hurst.

- **Virginia**

- In Virginia, approximately 140 service members, who arrived March 26, supported one CVC in one city from March 31 to May 22.
 - One, approximate 140-person, Type 2 Team from the U.S. Navy supported the federal pilot Type 2 CVC at the former Macy's in Military Circle Mall in Norfolk.

- **Washington**

- In Washington, approximately 100 service members, who arrived March 26, supported one CVC in one city from March 31 to May 25.
 - One, approximate 100-person, tailored Type 2 Team from the U.S. Army, modified at the request of the state to meet tailored Type 2 CVC requirements, supported the federal pilot CVC at State Fair Park in Yakima.

- **Wisconsin**

- In Wisconsin, approximately 140 service members, who arrived April 2, supported one CVC in one city from April 7 to May 28.
 - One, approximate 140-person, Type 2 Team from the U.S. Army supported the federal pilot Type 2 CVC at the Wisconsin Center in Milwaukee.

DoD Community Vaccination Center Support

As part of the whole-of-government response to the COVID-19 pandemic and sourced from Active Duty personnel previously identified before February 2021 to support the effort.

- **New Jersey**

- In New Jersey, 100 service members supported 11 CVCs in eight cities.
 - One, 25-person, Type 4 Team from the U.S. Army and U.S. Navy, who arrived Feb. 11, supported the federal pilot Type 4 CVC at the First Baptist Church of Lincoln Gardens in Somerset and the federal pilot Type 4 CVCs at Calvary Baptist Church and the Cathedral of St. John the Baptist, both in Paterson, from Feb. 14 to April 10.
 - One, 25-person, Type 4 Team from the U.S. Army, who arrived Feb. 19, supported the federal pilot Type 4 CVCs at Iglesia Pentecostal Church and Trenton Central High School, both in Trenton, and the federal pilot Type 4 CVC at BB&T Pavilion in Camden from Feb. 22 to April 16.
 - One, 25-person, Type 4 Team from the U.S. Army and U.S. Navy, who arrived Feb. 19, supported the federal pilot Type 4 CVC at Thomas G. Dunn Sports Center in Elizabeth and

the federal pilot Type 4 CVC at the Maureen Collier Senior Center in Jersey City from Feb. 22 to April 16.

- One, 25-person, Type 4 Team from the U.S. Army and the U.S. Navy, who arrived March 11, supported the federal pilot Type 4 CVC at St. Matthew AME Church in City of Orange and the federal pilot Type 4 CVCs at Raphael Hernandez Elementary School and Jehovah-Jireh Praise & Worship Church Center, both in Newark, from March 15 to May 7.

- **U.S. Virgin Islands**

- In the U.S. Virgin Islands, 25 service members, who arrived Feb. 26, supported two CVCs on two islands.
 - One, 25-person, Type 4 Team from the U.S. Army and U.S. Navy supported the federal pilot Type 4 CVC at the University of the Virgin Islands campus on St. Thomas and the federal pilot Type 4 CVC at the Morris F. deCastro Clinic on St. John, from March 1 to May 7.
